There will be a cones course set up for practice. So bring your stopwatch and have someone time you (and reset cones)!! If you want help in cones – just ask Peter!

In exchange for being permitted to participate in these activities, for myself, my heirs, guardians and legal representatives, I release and agree no to make or bring claim of any kind against The Aiken Driving Club, officers, the organizing committee, members, guests or any land owners, landholders or other persons making property available for The Aiken Driving Club, for any injury (including death), to me or any damage to my property whether from anyone's negligence or not, or any other cause, arising from my participation in these dangerous activities; and I also agree if anyone makes any claims because of any injury to me (including death), or for any damage to my property, I will keep all those released by this agreement free of any damages or costs because of those claims.
